### **PE&RS Single Site License**

For the purposes of a Single-Site License, all institutions must be in a single geographic region, containing one contracting organization for the license, one faculty, one set of programs, one library catalog, one administration with one mailing address for billing purposes, and one set of resources across all locations.

For institutions that have multiple locations in the same geographic region that are administered independently, each location is considered a different site. No access from remote campuses or remote sites and no consortia or other forms of subscription sharing are allowed under the Single-Site License.

### **Multi-Site License**

A Multi-Site License applies to institutions with locations in more than one geographic region or institutions that have multiple locations in the same geographic region that are administered independently.

Access from remote campuses or remote sites, and consortia or other forms of subscription are allowed under this license.
